

# State Conference Showcase Application • Due 2nd Week of December

- A non-refundable, \$50.00 fee is due at least one week prior to your show if you wish a live evaluation.
- Conference Showcase productions will be announced at the Regional Acting Competitions.
- Only shows that have not been presented at the conference in the last three years are eligible.
- You need not be an ITS member troupe to present at the State Conference.
- The show must have been performed between the third week in January of the previous year and the third week in January of the current year.
- Presenting schools receive \$100.00 and will be reimbursed for any royalty charges. All other costs associated with producing the show at State are the responsibility of the school.
- The presenting school will submit to any reasonable restrictions the conference host places on the production, including lighting and set restrictions, or material objections. All fire and safety codes in place at the host school will be stringently adhered to. ~~See P. 31 for complete submission guidelines & rules.~~
- The presenting school is not required to register the entire cast and crew for the conference, but may have them attend only for the performance. The presenting school is still bound by the same attendance number restrictions as the other schools.
- Sponsors from showcasing schools are expected to serve on the following year's selection committee.
